RCCN Travel Award: Large Pre-Trained Models with a Focus on AD/ADRD and Healthy Aging Workshop

Application Deadline: November 24, 2023

The Johns Hopkins University AI & Technology Collaboratory for Aging Research (JH AITC) is leading a 1-day workshop on generative AI (e.g., ChatGPT) for healthy aging on December 14, 2023.

Travel awards to attend the workshop in person are available for up to 10 early-career investigators who are affiliated with at least one NIA-supported center program belonging to the RCCN.

The <u>Johns Hopkins University Catalyst Awards</u> are for early-career faculty across the university who are undertaking exceptional research or creative endeavors. The awards of up to \$75,000 will help these individuals launch their promising careers during the crucial years when startup funds are depleted and external funding or other support may be elusive. They are available to faculty members appointed to a full-time

tenure-track or tenure-track equivalent faculty position within no less than three years and no more than 10 years of July 1, 2024.

The <u>Johns Hopkins University Discovery Awards</u> focus on cross-university, faculty-led research and discovery. We aim for these awards of up to \$100,000 to spark new interactions among faculty from across the university. Faculty teams use these funds to get started while they seek an externally funded large-scale grant or cooperative agreement.

The application deadline for both programs is midnight on Thursday, Feb. 15.
